SECRETARY REPORT

SOLICITOR REPORT

Attorney Logsdon reported on the following: 1) by agreement of all Council present, an emergency item has been added to the agenda, regarding submitting a tax appeal to Luzerne County on the tax assessment appeal filed by the owner of the former Holy Family Church on Main St. to lower the amount of taxes paid on that property. Council gave Attorney Logsdon permission to file an appeal against this and to contact the school district so we can work with them on this situation. 2) Opened the 3 bids received for the engineer consultant on sewer project, Council discussed but needed more time to review all bids thoroughly, Attorney will email to everyone for further review. 3) WVSA will be invited to attend a future meeting to present to Council taking over the sewers in Sugar Notch. 4) He reported for the Code/Zoning Officer in his absence that a hearing is scheduled regarding the zoning appeal of a fence and pool, he will confirm date with Zoning Board. 5) Explained to Council what a Quality-of-Life Ordinance can do for the Borough which is getting folks to correct a violation quicker by using a NOV (Notice of Violation) ticket. He will bring a draft Quality-of-Life Ordinance to next meeting for Council to review and discuss. 6) Discussed the specifics of the upcoming LSA County Grant and reminded Council it is due by the end of September. 7) He has tried again to contact the woman that set up new website regarding the domain name and has not heard from her yet. 8) On Monday at 9 am there is a meeting with April Hannon from Penn Dot regarding the Multimodal grant. 9) The Sesquicentennial Committee would like Council's permission to have a case built at Borough building for history items of Sugar Notch and also would like to plant a Christmas tree in front of Borough building to put lights on every year. They would be paying for this from funds leftover from the Sesquicentennial. Council said yes to history case however will wait on tree request due to some upcoming landscaping at the Borough building. Dominick will let the Committee know. 10) Discussed the Brook St. project and having John Leiphart do the work and Borough will purchase the supplies. He was the only person who bid on project.

Motion 2 – to accept John Leiphart's bid for the Brook Street Sewer Project in the amount of \$25,398.75, with the Borough purchasing all the supplies thru Costars. Motion Dominick Panetta.
